## McComb Cloe Griener Park

### Rules and Regulations

Thank you for your interest in McComb Cloe Griener Park facility reservation. Your reservation fee entitles you to the exclusive use of our reserved picnic shelter(s) in the park. The remainder of the park is public domain and receives heavy visitation during the warm weather seasons. Total exclusion of the public from your reservation area is not guaranteed.

- Park is open 24/7
- Reservations are on a first come first serve basis by calling the administration office at 419-293-3521
- Reservation form must be submitted with the proper fee to make your reservation
- Reservations can be made starting January 1<sup>st</sup> for the current year
- Applicant should bring a signed copy of the reservation form to their event for proof of the reservation
- Applicant must be present during the event
- Tables and furnishings must be returned to their original location
- Shelters and surrounding area must be left clean and in orderly condition
- All garbage and trash associated with the reservation/event must be cleaned up and placed in the trash receptacle at the conclusion of your event
- NO ALCOHOL is permitted in the Village Park
- Recreational burning is prohibited in the Village Park
- Grills may be used for cooking purposes only
- DO NOT put any hot coals from any grills in the trash receptacles
- Parking is allowed in designated areas ONLY

Applicant hereby agrees to be responsible for repairing or the cost of repairing any and all damage caused to the park and/or the reserved shelter reserved herein during the applicant's use of the park and shelter, including damage to equipment, furnishings, buildings and landscaping which may be related to the proposed activity at the reserved park and shelter. Applicant agrees to hold harmless the Village of McComb including its employees, from any and all liability for injuries or losses to persons or property that may result from any act or omission to act on the part of said individual or organization, or the acts or omissions of its employees or agents or anyone visiting the park and or shelter, or using any of the equipment, furnishings and buildings reserved herein, upon the invitation of said applicant, negligent or otherwise.
