- This permit may be revoked at anytime without notice
- ALL BADGES MUST BE TURNED IN AT THE END OF PERMITTED DATE(S) LISTED ABOVE OR RETURNED IN THE NIGHT DROP BOX IF AFTER HOURS OR A FEE OF \$20.00 PER BADGE WILL BE BILLED TO THE COMPANY LISTED ABOVE
