ORDINANCE NO. O-2018-06
VILLAGE OF MCCOMB, OHIO

AN ORDINANCE ESTABLISHING POSITIONS AND WAGES FOR SWIMMING POOL STAFF, RATES FOR 2018 POOL MEMBERSHIPS, AND POSITIONS EFFECTIVE APRIL 1, 2018 AND DECLARING AN EMERGENCY.

NOW, THEREFORE, BE IT ORDAINED by the Council of the Village of McComb, Ohio, two-thirds (2/3) of all members elected thereto concurring:

SECTION 1: That the following positions at the stated wages are hereby created:

| A. Pool Manager | \$11.00 per hour |
| B. Assistant Manager | \$10.50 per hour |
| C. Life Guards | \$8.50 per hour |

The above is intended as a minimum guideline for the establishment of wage levels. Council may at its discretion provide for a higher pay scale level for each position listed.

SECTION 2: That the following fees are established for use during the 2016 season, and that all memberships are paid in full before they can be used

<u>An Additional \$15.00 per family member after 5 Members</u> |
| G. Non-profit Organization | \$ 4.00 per day per person |
| H. Pool Parties | \$ 60.00 (Plus Cost of Lifeguards is renter's responsibility)** |
| I. Senior Citizens 63 & Older | Free |
| J. Village Employees & Immediate Family | Free |

**** \$30.00 of the \$60.00 Pool Party deposit is non-refundable upon cancellation for reasons other than:**

Cancellation due to an extreme emergency, the entire \$60.00 will be refunded.

Inclement weather, the pool party can be rescheduled for another date. If not rescheduled the entire \$60.00 will be refunded.

A refund check will be issued for all refunds. No Cash refunds will be made

SECTION 3: Village will reimburse pool personnel, up to \$50.00, for the purchase of an appropriate swimsuit. Receipts for the purchase must be turned in to the Pool Manager who will submit them to the Fiscal Officer's office for reimbursement processing. A check will be issued for the reimbursement.

SECTION 4: Pool personnel who complete the season will be reimbursed for fees associated with the certification/recertification of CPR and lifeguard training. Receipts for the reimbursement must be turned into the Pool Manager who will submit them to the Fiscal Officer's office for reimbursement processing at the end of the pool season.

SECTION 5: This Ordinance is hereby declared to be an emergency measure for the immediate preservation of the public peace, health and safety of the Village of McComb, Ohio, and for the further reason it is immediately necessary to enact said new pay rates and membership fees so that they will be effective with the upcoming Park and Pool season.

WHEREFORE, This Ordinance shall take effect and be in force from and after the earliest period allowed by law and approval by the signatures below.
